The details needs to be given while preferring fund requisition for subsequent weeks. Each Fund Requisition should be accompanied by this detailed breakup and preferred only after utilizing the fund for the head of Account against which it is transferred in previous requisition. The same needs to be certified by the Accounts Officer having utilized the fund.
