Preamble:

As per amendment dated 09.12.2019 to Regulation 14(A)(1)(e) of KEB Employees' (Classification, Disciplinary, Control and Appeal) Regulations, 1987 the Sub-Committee of the Board was delegated with the power to take action in accordance with the provisions of Sub-Regulation (21) and Sub-Regulation (23) of Regulation 11 and Regulation 11(A) and to impose any of the penalties specified in Regulation 9 in accordance with the recommendations of Hon'ble Lokayukta/Uplokayukta.

Subsequently, the BoD in its 121st Meeting held on 09.09.2020 resolved to delegate these powers to the Managing Director, KPTCL to take action on receipt of Enquiry Report and Recommendations of Hon'ble Lokayukta/ Upalokayukta. If the Managing Director, KPTCL is not in agreement with the report or recommendations, the subject shall be placed before the Sub-Committee for examination and recommendations to the Board.
