PREAMBLE:

The revision of pay scale and allowances of employees takes place periodically based on the Settlement entered into between the Management and the Employees' Union. As per the earlier settlements it was agreed to extend the Pensionary benefits including family pension, as prevailing in the State Government from time to time. In view of the different dates of effect of Revision of pay scales for employees of KPTCL and the Revision of pay scales & Pensionary benefits by State Government several anomalies have occurred in Pensionary benefits to KPTCL employees/pensioners. These anomalies have also given rise to prolonged litigation and unavoidable financial burden to the Corporation. To avoid anomalies in Pensionary benefits, Management has decided to revise the same along with revision for employees from the same date at the same rate.



Accordingly, Agenda was placed before the Board of Directors' meeting for approval. In the 108th and 109th Board of Directors Meeting, the proposals for revision of Pension/Family Pension of KPTCL Pensioners and Family Pensioners along with the pay revision of Employees with effect from 01.04.2017 at the same rate has been approved.

Hence the following order:-

The Corporation is pleased to accord approval for the Pensionary benefits of the Employees' retiring / expired on or after 01.04.2017 and Pension / Family Pension of the Pensioners / Family Pensioners existing as on 31.03.2017 consequent to revision of Pay Scales to the Employees' of the KPTCL w.e.f. 01.04.2017 in the following manner.

A. Revision of Pensionary Benefits:

For the Employees' retiring / expired on or after 01.04.2017:

1. Minimum Pension:

The Minimum amount of the following kinds of Pension admissible under the KEBESRs shall be enhanced to ₹8,185/- per month (i.e 50% of the Minimum Pay in the lowest time scale of pay in KPTCL) w.e.f. 1st of April 2017.

- (i) Superannuation Pension;
- (ii) Retiring Pension;
- (iii) Invalid Pension;
- (iv) Compensation Pension;

2. Maximum Pension:

The ceiling on the maximum amount of various kinds of pension mentioned in Para 1 above shall be fixed at ₹61,120/- per month (i.e. 50% of the Maximum Pay in the highest time scale of pay in KPTCL) w.e.f. 1st April 2017.

3. Family Pension:

a. The rates of Family Pension admissible as per KEBESRs shall be 30% of the emoluments subject to Minimum of ₹8,185/ per month (i.e. 50% of the Minimum Pay in the lowest time scale of pay of KPTCL) and Maximum of ₹36,672/- per month (30% of the Maximum pay in the highest time scale of pay in KPTCL) in respect of Employees' who put in a continuous service of not less than one year, and died/ dies while in service or retires on or after 1st April 2017.

- b. In the case of an employee who dies while in service after having rendered a qualifying service of not less than 7 (seven) years, the family pension admissible under the KEBESRs shall be at an enhanced rate equal to 50% of the emoluments last drawn or twice the Family pension normally admissible, whichever is less, for a period of 7 (Seven) years or till the date on which employee would have attained the age of 65 years, if he had survived whichever is earlier
- c. In the event of the death of both father and mother who are KPTCL Employees on or after first day of April 2017, the Family Pension payable to the minor children under the provisions of KEBESRs shall be subject to a maximum ₹36,672/- per month.

4. Dearness Allowance:

- a. The Pensioners including holders of Family Pension shall continue to be granted Dearness Allowance at the same percentage as is adopted in the case of regular Employees of KPTCL.
- b. In case of merger of Dearness Allowance with the Basic Pay is ordered by Government of Karnataka at a later date, the Minimum Pension/Family Pension and Maximum Pension/Family Pension as indicated above shall be revised appropriately.

5. Retirement Gratuity/Death Gratuity:

- a. The amount of Retirement Gratuity shall be paid as per their entitlement subject to a Maximum of ₹10.00 lakh (Rupees Ten Lakhs only) to the Employees' who retires on or after 1st of April 2017.
- b. In the event of the death of the Employee while in service on or after 1s of April 2017, the Death Gratuity shall be admissible at the following rates.

6. Emoluments:

The term Emoluments for the purpose of calculating various retirement and death benefits and family pension shall mean the Basic Pay drawn by an employee in the scale of pay applicable to the post held by him/her as on the date of retirement / death shall also include;

- (a) Stagnation/Elongation Increment if any granted to him/her above the maximum of the Scale of Pay.
- (b) Personal Pay, if any, granted to him/her under regulation 9(37) of the KEBESRs

7. Restoration of commuted portion of pension:

- a. In the case of an employee who commutes a portion of a pension under Regulation 256 of KEBESRs, the commuted portion of his pension shall be restored after 15 years from the date of commutation.
- b. Regulation 258 (9) of the KEBESRs, shall stand modified to the above extent. The order conditions regulating pension, gratuity, family pension and commutation of pension shall continue to apply.
- c. Regulation 258(10): The reduction in monthly pension on account of commutation under this rule shall be operative from the date of receipt of commuted value by the pensioner. In cases of revision of pension and payment of commuted value on the increase in pension further reduction in pension shall take into account from the date of payment of increase in commuted value on the increase in pension further reduction in pension shall take into account from the date of payment of increase in commuted value and not from the date of payment of original value.

As per the above Regulation, if the commutation of Pension has been given at different dates due to revision, the restoration of respective commuted value will be after completion of 15 years from the respective dates of Commutation.

B. Revision of Pension and Family Pension:

For the Pensioners and Family Pensioners of KPTCL prior to 01.04.2017.

1. Revision of Pension and Family Pension:

The Pension and Family Pension of the Pensioners / Family Pensioners existing as on 31.03.2017 (retired/death after retirement/died while in service prior to 01.04.2017) shall be revised in the following manner:

- (i) Basic Pension/Family Pension as on 01.04.2017.
- (ii) ADD 26% of Basic Pension /Family Pension as on 01.04.2017

The total amount computed as per (i) and (ii) above shall be fixed as Revised Basic Pension / Family Pension. If, the total amount computed as per (i) and (ii) above contain fraction of rupee, it shall be rounded off to next highest rupee as per KEBESR Regulation 217 note (3).

The total amount computed as per (i) and (ii) above shall be subject to a Minimum of ₹6,048/- per month for Pension/Family Pension and Maximum of ₹50,274/- per month and ₹30,165/- per month in respect of pension and family pension respectively.

2. Proportionate increase in Family Pension – In case of Family Pension is being drawn by two or more members of a Family:

Where family pension is sanctioned to two or more members of a family, the increase under this order shall be fixed as per procedure narrated under B(1) above considering share (Basic Family Pension) of each recipient.

3. Payment of arrears in case of Pensioners/Family Pensioners existing on 31.03.2017 and expired on or after 01.04.2017:

In respect of Pensioners / Family Pensioners existing as on 31.03.2017 and expired on or after 01.04.2017, the increase in Pension / Family Pension and arrears thereon if any, shall be paid to the persons entitled to receive Family Pension or to their legal heirs.

4. The Increase/Arrears of Pension /Family Pension as per this order shall be paid by the Pension Disbursement Officer without authorization from the concerned Pension Authorization Authority.

Other Terms and Conditions:

- a. All other Provisions, Rules, Conditions and Orders regulating Pension, Gratuity, Family Pension and Commutation of Pension, which are in force as on the date of this order shall continue to apply.
- b. Necessary amendments / insertions to the KEBESR and other rules will be issued separately.
- c. Merger of Dearness Allowance to the Basic Pension/ Family Pension will be regulated in line with merger of Dearness Allowance by the Government of Karnataka.

The Revision of Pension/Family Pension which was regulated as prevailing in the Government of Karnataka from time to time and followed hitherto as per earlier settlements shall cease to exist from 01.04.2017. However the Government Order No: FD(Spl) 27 PEN 2007 issued on 13.10.2010 with regard to enhancement of pension/family Pension attaining the age of 80, 85 and 90 years and above and adopted by KPTCL vide Order No: KPTCL/B16/18239/2010-11 dated 12.05.2011 will continue.

The revised Pension and Family Pension shall be drawn in the monthly Pension bills from the month of April 2018 and onwards. Separate orders will be issued with regard to payment of arrears consequent to revision of Pension and Family Pension.

The fixation of Revised Pension / Family Pension consequent to this order shall be subjected to Pre-audit before disbursement.

The Revision of Pensionary Benefits and Revision of Pension / Family Pension w.e.f 01.04.2017 in this order is applicable to the Employees' who joined service before 01.04.2006 and will not be applicable to those who are covered under the New Defined Contributory Pension Scheme.

Any difficulty encountered in the implementation of this order may be referred to Financial Advisor (A&R), KPTCL for clarification.

As such KPTCL in Order dated 21.06.2018 has accorded approval for treating 45.25% of Dearness Allowance as on 01.07.2017 as Dearness Pay w.e.f. 01.07.2017. Since emoluments includes Dearness Pay, the pensionary benefits is also to be calculated considering Dearness Pay/Mergeable portion of Dearness Allowance.

In case of merger of Dearness Allowance with the Basic Pay is ordered by Government of Karnataka at a later date, the Minimum Pension/Family Pension and Maximum Pension/Family Pension shall be revised appropriately. - c) All other contents of Order No: KPTCL/B16/69518/2017-18, dated 09.03.2018 shall remain unaltered.

The Revision of Pension/Family Pension which was regulated as prevailing in the Government of Karnataka from time to time and followed hitherto as per earlier settlements shall cease to exist from 01.04.2017. However the Government Order No: FD(Spl) 27 PEN 2007 issued on 13.10.2010 with regard to enhancement of pension/family Pension attaining the age of 80, 85 and 90 years and above and adopted by KPTCL vide Order No: KPTCL/B16/18239/2010-11 dated 12.05.2011 will continue.

The Revision of Pensionary Benefits in this Order are applicable to the Workmen joined the Pensionable Service before 1.4.2006 and will not be applicable for those who are covered under New Defined Contributory Pension Scheme.

The fixation of Revised Pension / Family Pension consequent to this order shall be subjected to Pre-audit before disbursement.
