

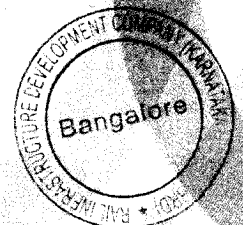

- Knowledge of Kannada is desirable.

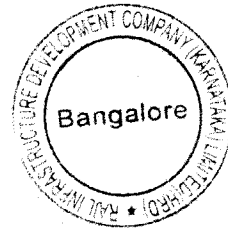
## VIII. INSTRUCTIONS FOR APPLYING:
