

1. Please refer to the GoK/Trust orders cited above.
2. As per GoK Notification/Order under reference-1 & 2 above, KPTCL and ESCOMs are required to make contribution towards the terminal benefits for their specified personnel under Second Transfer Scheme.
3. Accordingly, Actuarial Valuation of the Terminal Benefits (Pension and Gratuity) as at 31.03.2018 is required for KPTCL/ESCOMs as per IND AS 19.
4. I would therefore request you to arrange to furnish the soft & hard copy of the consolidated unit-wise employees'/Pensioners' data as per proforma 1 to 7 enclosed to this letter. Further, data in proforma 1 to 7 may be prescribed as "Annexure" to March Final Accounts 2018 to be submitted by all Accounting Units of your company to the Corporate Office. Soft copy of these proforma 1 to7 along with consolidated statement of your Company may please be arranged to be sent to this office during the month of April 2018 as the same has to be furnished to the Actuary.
5. As per the requirement of IND AS 19 (old AS 15) the Companies have to incorporate required adjustments in provision for terminal benefits based on the results of the Actuarial Valuation as at the end of the relevant financial year. Hence, data may please be provided positively by the end of April-17, so that results of Actuarial Valuation are obtained at the earliest and communicated to KPTCL/ESCOMs for complying with this requirement.
6. The macros enabled Excel format file in proforma 1 to 7 for Actuarial Valuation as at 31.03.2018 and word file containing instructions for filling up Proforma 1 to 7 is hosted in KPTCL web-site (path-> www.kptcl.com->eprasarana->Administrative->KPTCL and ESCOMs' Pension & Gratuity Trust->KEPGT Orders/Circulars).

7. The employees data furnished by the Accounting Units along with March Final Accounts 2018 may please be verified by the Corporate Office of the concerned companies before furnishing the same to Pension and Gratuity Trust.
