## **Preamble:**

KPTCL prepares estimates for both its Capital works and Revenue works based on the Schedule of Rates, which is revised from time to time, taking into cognizance the movement of prices in the open market to have realistic project estimates. Accordingly, the Schedule of Rates was revised in the year 2019 which came into effect from 01.06.2019.

Now, GoK vide Order cited under ref (2) has re-constituted a Technical Working Group (TWG) for preparation of UNI SR for the year 2023-24 in different volumes comprising of Schedule of Rates of various Departments such as PWD, NH & PRED, WRDO, MI & KPCL, BWSSB, KUWSDB & RWS, KPTCL, ESCOMs, Ports & IWTD & Airports, Forest, Watershed & Horticulture under the Chairmanship of the Retd., Chief Engineer, PWD and BESCOM is made as the Nodal Agency for KPTCL, ESCOMs & PWD Electrical.

As per the UNI SR concept, the entire State of Karnataka shall have common SR so that the same can be made use of by various Utilities like KPTCL, BESCOM, PWD etc. Schedule of Rates pertaining to Electrical works (Supply & Erection) is made part of the UNI SR under Volume - 6.

The Committee has discussed various issues related to revision of rates for finalization and compilation. Also, discussions were held with the Technical Working Group members of the UNI SR Committee for revision and preparation of UNI SR 2023-24.

UNI SR 2023-24 has been published in the PWD website and BESCOM website for adoption.

The subject "Adoption of UNI SR 2023-24" was placed in the 142<sup>nd</sup> Meeting of Board of Directors of KPTCL held on 01.12.2023 and the following Resolutions were passed:

RESOLVED THAT approval be and is hereby accorded to adopt and implement the UNI SR 2023-24 as proposed to be effective from 15<sup>th</sup> November 2023.


