Preamble:

- 1. The Clause No. 24.20 of Section-III, General Conditions of Contract (GCC) of Tender Document in respect of Civil works, deals with the rate to be considered for admitting payment for the quantities exceeding 25% of the tendered quantity of an item in the DWA.
- 2. As per the said Clause for quantities in exceeding of 25% of the tendered quantity of an item of Civil works in the DWA, the contractor shall be paid at the rates entered in the Schedule of rates (applicable for the area of the work and prevailing SR at the time of award of contract) plus the overall percentage of the original tendered rates over the updated estimate cost prevalent at the time of award of contract.
- 3. It is noticed that, in some of the instances the price admitted for the quantities exceeding the 25% over the DWA quantities as per the said Clause were found to be abnormal.
- 4. This issue was discussed in the 190th CPC held on 20/06/2020 and it was suggested to bring in amendment to the said Clause of the General Conditions of Contract (GCC) of Tender Document and further decided to place the said amendment before the Board for consideration and orders.
- 5. Accordingly, the subject was placed before the 121st Meeting of Board of Directors' of KPTCL held on 09/09/2020. The Board after examining the proposal, appreciated the financial implications with the incorporation of the amendment proposed to Clause no.24.20 of Section III, General Conditions of Contract (GCC) of Tender Document in respect of Civil works and resolved to incorporate the said amendment in all future tenders of KPTCL. Hence, this order.

The Clause No. 24.20 of Section III, General Conditions of Contract (GCC) of Tender Document for admitting payment for quantities exceeding 25% of the tendered quantities of an item in the DWA, in respect of Civil works, is amended as detailed below;

For Civil works:-

During the execution of the Contract, the Owner reserves the right to increase the Quantities of items under the Contract with a ceiling limit of 25% for each of the individual items without any change in unit rate or other terms and condition of the contract. For quantities exceeding 25% of the tendered quantity of an item in the DWA, the Contractor shall be paid at the rate entered in the Schedule of rates (applicable for the area of the work and prevailing SR at the time of award of contract) plus the overall percentage of the original tendered rates over the updated estimate cost prevalent at the time of award of contract.

In case of overall percentage on updated estimate cost being minus, then for quantities exceeding 25% of the tendered quantity of an item in the DWA, the contractor shall be paid at the Schedule of rates (applicable for the area of the work and prevailing SR at the time of award of contract).

For Civil works:-

During the execution of the Contract, the Owner reserves the right to increase the Quantities of items under the Contract with a ceiling limit of 25% for each of the individual items without any change in unit rate or other terms and condition of the contract. For quantities exceeding 25% of the tendered quantity of an item in the DWA, the Contractor shall be paid at the rate entered in the Schedule of rates (applicable for the area of the work and prevailing SR at the time of award of contract) plus the overall percentage of the original tendered rates over the updated estimate cost prevalent at the time of award of contract or the unit rate quoted by the Bidder as the case may be, whichever is lower without any ceiling limit.

In case of overall percentage on updated estimate cost being minus, then for quantities exceeding 25% of the tendered quantity of an item in the DWA, the contractor shall be paid at the Schedule of rates (applicable for the area of the work and prevailing SR at the time of award of contract).

The above amendment to Clause No.24.20 of Section III, General Conditions of Contract (GCC) of Tender Document shall be incorporated in all future tenders, by all the tender inviting authorities, with immediate effect.
