Preamble:

- 1. The Revised Manual of Delegation of Powers-2018, was approved in 109th KPTCL Board of Director's meeting held on 19/02/2018. Accordingly, Corporate order was issued vide No. KPTCL/B25/23720/2011-12 dated 21/03/2018 and 23/06/2018 which came into effect from 01/04/2018. Later, amendments to certain Delegations were issued in the Corporate orders dated 12/10/2018, 17/01/2019, 29/10/2020 and 15/02/2021.
- 2. In the Karnataka Transparency in Public Procurements Amendment Act 2020 (Karnataka Act No. 12 of 2020), exemption to applicability of the Act was provided in respect of procurement of Goods and Services including construction works and consultancy services of all types the value of which does not exceed Rs.5.00 lakhs. Accordingly, Corporate circular dated 05/09/2020, was issued for the said amendment.
- 3. As per Sl. No. 3.0413 of Manual of Delegation of Powers-2018, following delegation has been provided regarding award of services pertaining to surveying/ transportation of materials/ equipment on piece work basis.

4. There has been inordinate delay in fixing agencies for conducting transmission line surveys, in spite of having empanelled agencies. The rates being quoted by the agencies for transmission line surveys were far below the Schedule of Rates-2019.

As such, action has been taken to revise the Schedule of Rates-2019 for the items pertaining to surveying and geo-technical investigation works for transmission lines and substations.

5. Further, in order to speed up the process of conducting surveying and geotechnical investigation works for transmission lines and substations and to facilitate the CEE's and SEE's to award the surveying works to the empanelled agencies on piece work basis at the revised Schedule of Rates upto Rs.5.00 lakhs and Rs.3.00 lakhs respectively, a proposal was put up in the Corporate office note dated 19/02/2021, for amendment to the Delegation in Sl. No.3.0413 in the back drop of the amendment to KTPP Act. The proposal was approved pending ratification in the Board. Hence, this order.
