- Sub : Amendment to Clause No. 24.2 of GCC of Vol-I of the Tender Document for inclusion of Freak Rate clause in tender documents, admitting rates towards freak rate items reg.
- Ref : 1. Proceedings of 125th Board of Directors Meeting of KPTCL held on 24.06.2021 Subject No. 125/29.
 - I.O. Note No. KPTCL/B37/125th BM/2021-22/270-75 dated 23.07.2021 of the Company Secretary, KPTCL.

PREAMBLE:

Construction of Sub-stations, Transmission Lines and other system improvement works in KPTCL is being carried out by inviting tenders on Turnkey basis. Bidders are required to quote their unit rate along with F&I and applicable taxes against each material required for the project. The total contract price is being computed based on quantities stipulated and rates quoted by the Bidders duly de-loading excess tax component/F&I, arithmetic errors if any etc.

As the works of KPTCL are dynamic in nature, the quantities initially assessed while inviting tender may vary while the works are under execution. The prevailing tender condition as per Clause No. 24.2 of GCC, Vol-I, calls for payment towards additional quantities over and above the awarded quantities at the awarded rates only which is quoted by the Bidder.

Of late, it is observed that there is a tendency among the Bidders to quote either abnormally high or abnormally low (Freak Rate) rates for some of the materials. As such with the higher Freak Rates, if there is any increase in the quantities over and above the DWA quantities, then KPTCL is bound to pay at the DWA rates which are abnormally high without any ceiling limit. Hence, it is observed that, wherever the rates are abnormally high, there will be excess payment from KPTCL.

Therefore, with an intention to safe guard the interest of KPTCL, it is proposed to define "Freak Rate" under section GCC of Vol-I of the Tender document as "the unit rate of an item over and above 25% of the Schedule of Rates applicable at the time of according approval to award of contract".

In the above background, it is proposed to issue amendment to Clause No. 24.2 of GCC of Vol-I of the Tender document.

The subject proposal was placed before the 125th Board of Directors Meeting of KPTCL held on 24.06.2021 seeking approval to modify Clause No. 24.2 of GCC of Vol-I of the Tender document.

Board after detailed deliberations, approved the proposal for modifying the rates admissible for the quantities over and above the DWA quantities for freak rates quoted by the Bidder in future works of KPTCL with the following resolution:

"RESOLVED THAT approval be and is hereby accorded for the amendment to Clause No. 24.2 of GCC of Vol-I of the Tender Document and the same shall be adopted in the Tenders for future works in KPTCL".

1. To include the definition of *Freak Rate* under section GCC of Vol-I of the Tender document as below:

Freak Rate: The unit rate of an item over and above 25% of the Schedule of Rates applicable at the time of according approval to award of contract is defined as "Freak Rate".

2. Amendment in respect of Clause No. 24.2 of GCC of Vol-I of the Tender document and the same shall be adopted in the Tenders for future works in KPTCL as below:

Note:

Freak rate shall be determined based on the following:

1. <u>Schedule of Rates (SR) for supply portion</u> includes KPTCL Major Works Schedule of Rates or updated Major Works Schedule of Rates updated as per IEEMA/CACMAI and including all loading factors as per component abstract, as applicable at the time of according approval to award of contract.

Note: For materials which are not covered in KPTCL MWSR, the SR at the time of award shall be the same as DPR rates (approved rates) considered while arriving at the amount put to tender.

2. <u>Schedule of Rates (SR) for erection portion includes</u> KPTCL Major Works Schedule of Rates including all loading factors as per component abstract as applicable at the time of according approval to award of contract.

Note: For materials which are not covered in KPTCL MWSR, the SR at the time of award shall be the same as DPR rates (approved rates) considered while arriving at the amount put to tender.

3. <u>Schedule of Rates (SR) for civil portion includes</u> KPWD SR of the respective jurisdiction as applicable at the time of according approval to award of contract.

Note: For materials which are not covered in KPWD SR / KPTCL MWSR, the SR at the time of award shall be the same as DPR rates (approved rates) considered while arriving at the amount put to tender.

4. <u>Tender premium (TP)</u> is arrived at by comparing contract amount with Updated Estimated cost arrived by computing Major Works Schedule of Rates or updated MW SR as per IEEMA/CACMAI and KPWD SR of the respective jurisdiction and including all loading factors as per component abstract as applicable at the time of according approval to award of contract.

This order shall come into effect immediately.
