PREAMBLE:

Construction of Sub-stations, Transmission Lines and other system improvement works in KPTCL is being carried out by inviting tenders on Turnkey basis. Bidders are required to quote their unit rate along with F&l and applicable taxes against each material required for the project. The total contract price is being computed based on quantities stipulated and rates quoted by the Bidders duly de-loading excess tax component/F&l, arithmetic errors if any etc.

As the works of KPTCL are dynamic in nature, the quantities initially assessed while inviting tender may vary while the works are under execution. Off late it is observed that, Bidders are quoting abnormal rates (either high or very low rates) for some of the items in some Tenders which leads to excess out flow of payment from KPTCL to the Agency in the initial stage.

In the interest of the Corporation, it is proposed to modify "Stages of payment" i.e., Clause No. 8.2 & 8.3 of SCC of Vol-I of the Tender Document in the event of non-Freak Rates and Freak Rates.

The subject proposal was placed before the 125th Board of Directors Meeting of KPTCL held on 24.06.2021 seeking approval to modify "Stages of payment" i.e., Clause No. 8.2 & 8.3 of SCC of Vol-I of the Tender Document.

Board after detailed discussion, approved the proposal for *modifying the payment* conditions during freak rates quoted by the Bidders for future works in KPTCL with the following resolution:

"RESOLVED THAT approval be and is hereby accorded for the amendment to Clause No. 8.2 & 8.3 of SCC of Vol-1 of the Tender Document and the same shall be adopted in the Tenders for future works in KPTCL".
