The work of Design, Testing, Supply, Laying of 66kV 1000 Sq mm XLPE Copper conductor SC UG cable (including Civil Works), Testing and Commissioning for the following

1. Providing 66kV source to Nelagadarenahalli & Widia Sub-stations by running 66kV 1000Sq mm XLPE Copper conductor SC UG cable for a route length of 3.540km from the existing 66/11kV Nelagadarenahalli Sub-station to existing 66/11kV Widia Sub-station.
2. Running of 66kV 1000Sq mm XLPE Copper Conductor SC UG cable for a route length of 0.04km from proposed CTT at existing 66/11kV Widia Sub-station to proposed Hybrid switchgear 66kV Terminal Bay at 66/11kV Widia Sub-station.
3. Running of 66kV 1000Sq mm XLPE Copper Conductor SC UG cable for a route length of 0.098km from proposed Hybrid switchgear 66kV Terminal Bay at existing 66/11kV Byadarahalli Sub-station to proposed CTT at 66/11kV Byadarahalli Sub-station.

were awarded vide LOI (Letter of Intent) dated 16.12.2019 by the Chief Engineer (Electy.), Tendering & Procurement, KPTCL on Total Turnkey basis to M/s Pavani Controls & Panels Ltd. Hyderabad in consortium with M/s Cable Corporation of India Limited, Mumbai.

As per the scope of work in the tender document, the lead bidder M/s Pavani Controls & Panels Ltd. Hyderabad would lay the UG cable and the consortium partner M/s Cable Corporation of India Limited, Mumbai was vested with the responsibility of manufacturing and supplying of 66kV 1000 Sq mm UG cable after conducting type tests at CPRI. M/s Cable Corporation of India Limited, Mumbai has failed to perform their scope of work and also the contract agreement was not executed by both the lead bidder and the consortium partner duly furnishing the performance bank guarantee.

As per Clause 22.6 of ITB (Instructions To Bidders) of the tender document, "The Bid Security shall be forfeited besides Blacklisting of the firm for a period of one year:

b) In case of a successful Bidder, if the Bidder fails:

i) To sign the Contract,

OR

ii) To furnish the Performance Guarantee in the prescribed format".

As it is solely because of default of the consortium partner M/s Cable Corporation of India Limited, Mumbai, the subject tender had to be dropped which has resulted in delay in execution of the said projects.

Hence, M/s Cable Corporation of India Limited, Mumbai is barred from participating in all KPTCL Tenders for a period of one year from the date of issue of this Circular.

Further, it is instructed to remove M/s Cable Corporation of India Limited, Mumbai from the vendor list for a period of one year.
