

National Highways Authority of India (NHAI) had requested KPTCL to exempt returning of assets released during execution of shifting / modification of Transmission Line works by NHAI. In this regard, a Circular was issued vide ref(1) accepting the request of NHAI to exempt returning of assets released during execution of Transmission Line works under self-execution basis by NHAI. The same was placed before 119<sup>th</sup> Board of Directors Meeting held on 11.03.2020 for ratification. The Board has ratified and further resolved that "similar exemption may be accorded to NH(PWD) from returning of assets released during the execution of shifting / modification of Transmission Line works under Self-Execution basis by NH(PWD) provided that, if NH(PWD) creates lesser value assets compared to the original assets then the difference in the value of assets shall be returned to KPTCL store".

Hence, KPTCL exempts returning of assets released during the execution of shifting / modification of Transmission Line works under self-execution basis by NH(PWD) provided that only if NH(PWD) creates lesser value assets compared to the original assets then the difference in the value of assets shall be returned to KPTCL store.

This circular is applicable only to NH(PWD) which shall be effective from the date of this circular.

The above instructions shall be followed scrupulously.
