## Preamble:

The Power Sector Transmission system at Central level and State level are planned and implemented in the Country in co-ordinated efforts as per the National Electricity Plan (NEP) under the provisions of Electricity Act, 2003. A number of Regulations are being issued by the Central Commission on Transmission and Grid Operation related issues will have a direct bearing on the Finance of Distribution Companies (DISCOMs). As such the Regulations. Implementations or the Amendments to Regulations having impact on the Power Sector of State as a whole are to be handled in a co-ordinated manner by KPTCL (STU), SLDC and PCKL on behalf of DISCOMs of the State.

The implementation of CERC Regulations and amendments on Sharing of Transmission Charges and DSM has increased the financial burden on the DISCOMs. Sharing of Transmission charges is carried out through the PoC Mechanism in which all the DICs/State entities (State as a whole) are required to verify the Transmission Line parameters, line flows, furnish LGBR and debate the same in the Validation Committee meeting for enabling the fairness in computation of PoC. KPTCL (STU) & SLDC (and not the DISCOMs) are involved in the Transmission planning (attending CEA Standing Committee meetings and Joint studies by CTU/CEA), conversant with the Transmission Line flows into and out of the State Grid and also involved in furnishing the LGBR to the validation committee for PoC charge computation.

In order to safeguard the interest of the State, there was a need for proper co-ordination between KPTCL, SLDC and PCKL in behalf of DISCOMs in handling the Transmission and Grid operation issues and hence an Order was issued on 27.05.2019 for constitution of a Committee for co-ordination in Power Sector. Subsequently, Orders dated 19.11.2019 & 21.12.2019 were issued to nominate FA (RA) and nominate back EE (RA) as a Member of the Committee.

However, some of the designations in the Organisation have been changed consequent to promotions i.e., the post of Superintending Engineer (Ele.) has been upgraded to Chief Engineer (Ele.) and the designation of a Member has been changed from Executive Engineer (Ele.) to Superintending Engineer (Ele.). Hence, there is a need for re-constitution of the Committee for co-ordination in Power Sector.

Hence, this Order.
