It is usual practice in KPTCL to review the Major Works Schedule of Rates periodically so as to update the same with the prevailing market conditions. A Committee was constituted vide Order No. KPTCL/B19/7625/86-87 dated 19.10.2016 to review the Major Works Schedule of Rates. Accordingly, the Committee examined the various factors involved and recommended the revision of the Major Works Schedule of Rates. The revision of Major Works Schedule of Rates was approved vide Order No. KPTCL/B19/7625/86-87 dated 28.05.2019 w.e.f. 01.06.2019. On account of the dynamic market conditions, it has again become necessary to review the rates of various equipments and to revise the Major Works Schedule of Rates-2019. In the 99<sup>th</sup> Board of Directors Meeting of KPTCL, Board desired that Schedule of Rates shall be revised annually. As such, it is proposed to re-constitute the Committee for Revision of Major Works Schedule of Rates.
