Preamble:

In accordance with the decision taken in the 114th Board of Directors meeting of KPTCL held on 06.03.2019, Board Order dated 02.08.2019 was issued for sparing Idle/Spare KPTCL assets such as Transmission Line/Terminal Bays/11kV Switchgear etc., to Generators to facilitate the Generators for utilization of idle/spare KPTCL assets for construction of dedicated Transmission Lines/Terminal Bay.

Further, as per the decision of 119th Board of Directors Meeting of KPTCL held on 11.03.2020, another Order was issued on 23.09.2020 by withdrawing the Order dated 02.08.2019. Also, a clarification on the said Order was issued vide Circular dated 20.04.2021.

KERC notified the KERC (Sharing of Revenue derived by Transmission and/or Distribution Licensee(s) from other business) Regulations, 2020 on 05.03.2021. Further, KERC vide its letters dated 04.06.2021 & 28.06.2021 had directed KPTCL to modify the Order dated 23.09.2020 and the Circular dated 20.04.2021. In compliance with the said

Regulation, an Order was issued on 05.10.2021 for sparing KPTCL Land, Idle/Spare KPTCL Assets/Equipment to HT/EHT Consumers/Distribution Licensee/IPP superseding the earlier Board Orders dated 02.08.2019, 23.09.2020 & Circular dated 20.04.2021.

The Clause 5(6) of KERC (Sharing of Revenue derived by Transmission and/or Distribution Licensee(s) from other business) Regulations-2020 reads as under:

5 (6) Licensees shall ensure that at no point of time:

- *Renting/Leasing of its assets result in lack of available capacity for its consumers/generators, to carry out its own licensed activity.*
- *The safety of the assets of a licensee is compromised.*
- *Can lease/sell its assets including land without prior approval of the Commission in accordance with Section 17(3) of the Electricity Act, 2003.*

In view of the above provisions under KERC (Sharing of Revenue derived by Transmission and/or Distribution Licensee(s) from other business) Regulations-2020, it is decided to withdraw the Order dated 05.10.2021.

Hence this Order.
