CIRCULAR

Sub: Procedure for granting approval to Independent Power Producers (IPPs) for Interconnection with KPTCL / ESCOM Network to evacuate power in the State of Karnataka – Reg.

Ref: 1. T.O Board Order of even No. dated: 21.12.2015.

2. T.O Board Order of even No. dated: 26.09.2016.

3. T.O Amendment of even No. dated: 09.2.2017.

4. Note dated 30.12.2020 of CEE(P&C) approved by the Managing Director, KPTCL on 01.02.2021.

The Independent Power Producers (IPPs) in the State of Karnataka are being provided interconnection with KPTCL /ESCOM Network for evacuating the power generated from their respective power plants on completion of the evacuation scheme work as approved by KPTCL, based on the request of the IPP.

The Independent Power Producers (IPPs) are required to comply with the various technical and financial conditions before getting interconnected to the KPTCL Transmission system / ESCOM Distribution Network. The interconnection approvals are being processed based on the documents being furnished by the IPPs at the time of seeking such approvals. It is observed that, some of the IPPs are seeking interconnection approvals by furnishing few documents, leading to granting interconnection approvals with certain time limit to furnish the balance documents.

In such cases, KPTCL has been allowing provisional interconnections subject to certain conditions varying from case to case based on the specific issues. However, in the recent past, the Independent Power Producers (IPPs) are not furnishing the balance documents in time to regularize their

interconnection approvals thereby continuing to stay on provisional interconnection for very long duration by seeking repeated time period extensions for the same. Therefore it is necessary to have compliance in full by the Independent Power Producers (IPPs) before seeking grant of regular interconnection.

In order to streamline the process of granting timely interconnection approval and to enable the Independent Power Producers (IPPs), to evacuate power generated by them for use of consumers, KPTCL is required to issue a standard procedure for the purpose of optimum utilization of the resources in the State.

In view of the above facts and considering the various issues involved, it is proposed that while communicating approvals to the Independent Power Producers (IPPs) in the State of Karnataka who are seeking interconnection to KPTCL /ESCOM Network, the following procedure shall be observed:

- I. <u>Interconnection approval</u>: This approval shall be granted only when the requisite documents are furnished as per the checklist of documents indicated in Annexure to this Circular. However, in case certain documents are not furnished, such cases shall be allowed for provisional interconnection pending submission of documents. Such approval shall be granted for a period of 06 months and the IPP shall regularise the same within this period.
- II. <u>Time period extension for the provisional interconnection</u>: This approval shall be granted based on the specific request made by the IPPs for a further period. In case, time period extension for provisional interconnection is required to be extended, such specific cases shall be reviewed by the Director (Transmission), KPTCL and the special circumstances leading to such extension shall be recorded before recommending for approval from the Managing Director, KPTCL.

Interconnection approvals as stipulated in above cases (I & II) to Independent Power Producers (IPPs) are not binding on KPTCL to accord such approval in case, if any complications / disputes / legal issues / financial obligations / non-compliances of any kind, any nature that are prevailing / that may arise in future with regards to any specific project and to be reviewed on case to case basis.

The above instructions shall be scrupulously followed while granting the interconnection approvals from the date of this Circular as per the powers vested with them as stipulated in the Revised Manual of Delegation of Powers 2018 and as per the Board Order no: KPTCL /B28 (a) /20961 /2015-16 dated: 21.12.2015 & 09.2.2017 with amendments issued from time to time.

KPTCL reserves the right to alter / modify / add / delete the number of documents under the checklist annexed to this Circular.
