Preamble:

The Chief Engineer (Ele), Transmission Zone, Bengaluru, in his Note dated 02.02.2018, had requested approval for payment of land compensation for securing Right of Way (RoW), in respect of on-going transmission lines in Ramanagara & Chikkaballapura Districts, as per the passed by the Deputy Commissioners of Ramanagara Chikkaballapura Districts. As directed by the Hon'ble Minister for Energy & Chairman, KPTCL, on the said note and foreseeing urgency in completion of works, Corporate office vide letter dated 08.02.2018, communicated approval for payment of land compensation for securing Right of Way (RoW) in respect of on-going transmission lines in Ramanagara and Chikkaballapura Districts, subject to placing the subject in the next Board of Directors' meeting of KPTCL, for obtaining post facto approval.

Accordingly, the subject of payment of compensation for securing Right of Way (RoW) in respect of on-going transmission lines in Ramanagara and Chikkaballapura Districts, was placed before the 109th meeting of Board of Directors' of KPTCL held on 19th Feb 2018. In this regard, the Board has resolved as below.

"Resolved that for the reasons explained, action taken by Deputy General Manager (Tech), KPTCL, in communicating necessary approval vide letter No: SA8/B7/19105/15-16, dated 08.02.2018, for making necessary payment towards land compensation to the farmers in Ramanagara District and Chikkaballapura District, as of Deputy Commissioner, Ramanagara the orders Chikkaballapura Districts be and is hereby ratified".

While on the above subject, the Board noted that from henceforth, the aspect of compensation for diminution in the usage of land with respect to tower foot area and line corridor area would be a perennial phenomenon. Expeditious disposal of such Right of Way issues is in the best interest of the organization so that completion of the concerned work does not hit any Road Block. Such proposals involving Compensation towards land for Tower Foot Area and Line Corridor Area are being addressed with reference to the Compensation amount fixed by the respective Deputy Commissioner. In order to expedite such issues, Board has further passed the following resolution:

"Resolved that Managing Director, KPTCL, be and is hereby authorized to approve payment of compensation with respect to the Tower Foot Area and Line Corridor Area, as per rates approved by the respective Deputy Commissioner in respect of Transmission Line works undertaken by KPTCL.

Further, resolved that subject to the above Deputy General Manager (Technical), KPTCL, be and is hereby authorized to issue necessary orders accordingly".
