Preamble:

The Manual of Delegation of Powers-2018 was approved in 109th Board of Directors meeting held on 19.02.2018. Accordingly, Corporate Order was issued vide No. KPTCL/B25/ 23720/2011-12 dated 21.03.2018 & 23.06.2018 which came into effect from 01.04.2018 followed by amendment to the Manual of Delegation of Powers-2018 vide Corporate Order dated 12.10.2018, 17.01.2019, 05.09.2020, 29.10.2020, 15.02.2021 & 20.02.2021.

GoK vide Gazette Notification dated 27.04.2020 has issued an amendment to section 4 of Karnataka Transparency in Public Procurements Amendment Act 2020 (Karnataka Act No.12 of 2020) wherein exemption to applicability of the Act was provided in respect of procurement of Goods and Services including construction works and consultancy services of all types, the value of which does not exceed Rs.5.00 Lakhs.

However, as per Sl. No. 3.0123 of Manual of Delegation of Powers-2018, the powers delegated can be exercised without inviting tender in case of emergency only, but the same cannot be exercised in regular condition. Also, Sl. No. 3.0222 is applicable for both Electrical and Civil Works and hence awarding only Electrical works not exceeding current KPTCL SR / BESCOM SR on piece work basis without calling tender is not at all possible. Thus, all the minor works costing Rs. 5.00 Lakhs and below has to be carried out only by inviting tender through e-procurement portal which takes about 5 to 6 months for the whole process. Further, the tender has to be recalled time and again due to single bidder participation.

Hence, in order to complete the works in time and to maintain the Transmission System Availability of 99.75% as per KERC guidelines and in view of the amendment issued to

Hence, in order to complete the works in time and to maintain the Transmission System Availability of 99.75% as per KERC guidelines and in view of the amendment issued to section 4 (e) (i) of KTPP Act vide GoK Gazette Notification dated 27.04.2020, it is proposed to amend Sl. No. 3.0123 and to include a new clause under Sl. No. 3.0328 for procurement of Goods / Materials of Manual of Delegation of Powers 2018.
