The Karnataka Power Transmission Corporation Limited is pleased to further amend the Karnataka Electricity Board Recruitment and Promotion Regulations as hereunder:

### 1. TITLE AND COMMENCEMENT:

- These Regulations shall be called the Karnataka Electricity Board Recruitment and Promotion (Amendment) Regulations, 2020.
- These shall come into force with effect from 09.09.2020.

### 2. AMENDMENT TO SUB CLAUSE (e) UNDER CLAUSE-17-RELAXATION OF REGULATIONS RELATING TO APPOINTMENTS, AGE AND RESERVATION OF VACANCIES IN CHAPTER-I OF THE KARNATAKA ELECTRICITY BOARD RECRUITMENT AND PROMOTION REGULATIONS:

The conditions stipulated in sub-clause (e) under clause-17 – Relaxation of Regulations relating to appointments, age and reservation of vacancies in Chapter-I of the Karnataka Electricity Board Recruitment and Promotion Regulations, shall stand amended as hereunder:-

Clause	As existing	As amended
17 (e)	in the case of employees already working in the Board the age limit shall be relaxed by <b>SEVEN YEARS</b> or the number of years of service rendered by him, whichever is less, over the age limit prescribed for applicants for direct recruitment to any category of post in the Board.	in the case of employees already working in the Corporation the age limit shall be relaxed by <b>TEN (10) YEARS</b> or the number of years of service rendered by them, whichever is less, over the age limit prescribed for applicants for direct recruitment to any category of post in the Corporation.
