- 1.3 Taxes:
- 1.31 During contract period, if there is any concession/reduction in the GST by the changes in the policies by the Central/State Government, the same shall be availed and passed on to KPTCL.
- 1.32 During contract period, if there is any enhancement in the statutory taxes like GST, due to change in the policies by the Central/State Government, then such enhanced taxes will be payable by KPTCL.

1.4 Payment:

Payments will be arranged at respective Accounting Divisions of concerned officers of KPTCL who are using vehicles. Your Agency shall submit the bills for payment of vehicle hired charges to the respective Accounting Divisions of concerned officers of KPTCL who are using vehicles by 5th of the succeeding month. Payment will be arranged by Cheque/RTGS by the respective Accounting Divisions subject to the following:

- 1) For each vehicle one bill for each month (or part thereof) shall be raised by your Agency.
- 2) Following documents shall be attached to the bill:
 - i. Log Book extract signed by concerned officer of KPTCL who are using the vehicle.
 - ii. Copy of RC Book
 - iii. Copy of Tax & Permit Certificate
 - iv. Copy of Insurance Certificate
 - v. Copy of Emission Certificate
- 3) The bill shall be certified by the concerned officer of KPTCL who are using the hired vehicle and countersigned (wherever required) by the superior officer of the concerned officer.
- The bill shall be submitted to the Accounting Division of concerned officer of KPTCL.
- 5) Any other relevant documents which may sought by the Accounting Division of KPTCL relating to compliance to statutory requirements as may be applicable now and as amended from time to time which includes compliance with the Employees State Insurance Act, Employees Provident Fund Act, Payment of Minimum Wages Act and any other Labour Act as may be applicable from time to time.
- 6) Payments shall be adjusted for deductions for retention, other recoveries in terms of the contract and taxes, at source, as applicable under the law.

1.5 Period of Contract:

The initial contract is for a period of One (01) Year from 16.06.2022 (extendable for one more year on satisfactory service).

2. Scope of Contract:

You shall Provide 621 Nos. of Commercial vehicles to KPTCL on hired basis for the use of officers of various offices of KPTCL in Karnataka State for a period of One year as per the details furnished below.

- a) 58 Nos. Swift Dzire/Toyota Etios or Equivalent specifications AC vehicles.
- b) 173 Nos. Tata Sumo, Mahindra Bolero, Force Trax or Equivalent specification Non-AC Vehicles.
- c) 390 Nos. Tata Indigo/Tata Indica/Swift or Equivalent specifications Non-AC Vehicles.

Note:

- 1. You are at a liberty to provide high end vehicles in place of the above vehicles at no extra cost to KPTCL.
- 2. The number and type of Vehicles required by KPTCL is indicative and KPTCL at its absolute discretion may increase or reduce the number and type of vehicles during the contract period as per the actual requirement of KPTCL.
- 3. The list of offices and officers where vehicle needs to be provided is enclosed to the Detailed Work Award as Annexure-B.

3. General Terms & Conditions:

- 1. Your Agency shall provide drivers along with vehicles.
- 2. The number of vehicles indicated is provisional; it may vary as per actuals.
- 3. Your Agency shall provide commercial yellow board vehicles only.
- 4. The Vehicle should be available for all the days during the month including holidays.
- 5. The service of Commercial vehicles is to be provided on all week days from Monday to Saturday ranging from 6-00 AM to 10-00 PM or as specified by the concerned KPTCL officer depending upon the requirement of the officer. Requirement of vehicle on Sundays and Holidays if any will be intimated by the officer concerned and is to be arranged accordingly.
 - a) Normal usage of the vehicle is for about 12 hours on any day and 300 hours per month cumulative. Usage of vehicle beyond this time period will be treated as additional service for which extra hour charges beyond 300 hours will be paid at the awarded rates.
 - b) Normal usage of the vehicle is considered for 2500 km per month Cumulative. Charges for extra kilometer beyond 2500 km per month will be paid at the awarded rates.
 - In case vehicle is not provided by service provider or if the concerned officer proceeded on casual leave or any kind of leave, for such instances 1/30th portion of Monthly Hire charges will be deducted for non-availability of vehicle for each working day.
 - c) The payment will be made for actual extra kilometers and extra hours run by the vehicles computed on monthly basis over and above 2500km and 300hour.

- However, for vehicles used by RT, TCD and R&D sections, the extra kilometers and extra hours used over and above the daily average will be paid extra on daily average basis at the awarded rates(Refer Annexure-A).
- d) When additional requirement of Vehicles required during contract period, you shall provide additional requirement of Vehicles in shortest notice time. The concerned KPTCL officials shall obtain approval from Director (A&HR), KPTCL before obtaining services of additional vehicle.
- e) No extra driver bata will be paid by KPTCL.
- 6. In case of any dispute of any kind and in any respect whatsoever, the decision of KPTCL shall be final and binding.
- 7. Your Agency shall comply with all the rules and regulations relevant to supply and running of commercial yellow board taxis stipulated by RTO, Karnataka and other Government Authorities. Your agency shall comply with all the local/ municipal laws and statutory rules as applicable and will indemnify the KPTCL against all actions, claims, suits etc. for non-compliance of laws.
- 8. As the drivers are employees of your agency, you shall comply with local laws and provisions relating to their employment with your agency. The KPTCL will not be liable for their non-compliance.
- 9. Your agency shall have all valid permits for commercial usage, RC book, insurance, copy of Tax & permit certificate, pollution certificate etc., from concerned departments and the copy of the same shall be furnished before providing the vehicles to concerned officer of KPTCL and Accounting Division. Originals of all the documents shall be produced to the verification of concerned officer of KPTCL and Accounting Division.
- 10. Your Agency is bound by PF Act, ESI Act and other statutory provisions that may arise from time to time.
- 11. Your Agency will have to pay the drivers as per the Minimum Wages Act applicable as per Central Government Labour laws. Since the driver will be the employee of your agency, therefore any rise in the minimum wages has to be borne by your Agency and cannot be charged to the KPTCL. Your Agency has to take all the incidental charges into account.
 - It is the responsibility of your Agency to comply with all the rules and regulations of Government Authorities, local/ municipal laws, PF Act, ESI Act, minimum wages Act, provisions under Contract Labour (Regulation & Abolition) Act 1970 and other statutory rules.
- 12. Your Agency shall provide a single contact person/ supervisor for the fleet deployed for each of Transmission zone (Total 6 Nos. of supervisors shall be provided, i.e.1 supervisor for each of Transmission zone of Tumkur, Mysuru, Hassan, Bagalkote, Kalaburgi and one Supervisor for Bengaluru Transmission zone and SLDC & KPTCL Corporate office). It would be the responsibility of the supervisors to keep track of the vehicles, also any instruction regarding vehicles would be communicated to the supervisor through phone or whatsapp. It would be the responsibility of the supervisor to ensure that the vehicle reaches the desired location and report to the desired officer within time.
- 13. Your Agency shall provide the vehicle of the make/model, type as per the terms of the contract during the entire period of contract and should not change the vehicle without prior information and approval from KPTCL. In emergency and rare



- circumstances, this condition can be waived off by the concerned officer of KPTCL temporarily.
- 14. All expenses relating to salary and allowances of the driver shall be borne by your Agency. Like-wise all expenditure related to the vehicle including insurance, spare parts, breakdown cost, maintenance & fuel, oil etc. will also be borne by your Agency and no other charges will be paid by KPTCL.
- 15. Your Agency shall ensure that the vehicle deployed shall have clean seat covers/towels, car perfume and should be in good running condition for which no extra cost payment would be made.
- 16. LPG Cylinders should not be used for running the vehicle in any case.
- 17. Your Agency shall ensure that the drivers deputed for service do not have any police records/ criminal cases(previous or pending) against them. Your Agency shall make adequate enquires about the antecedents of the drivers before deputing them for service.
- 18. The drivers should always remain with the vehicle during the entire period of duty. In case of any need, they should seek permission from the concerned officers.
- 19. The vehicle should be cleaned every day and in compliance with the COVID-19 safety measures.
- 20. The driver should be provided with white uniform and shall always possess valid Taxi driving license and badge in the vehicle. Driver should have good character and experience in driving.
- 21. A mobile phone in good working condition has to be provided to the driver by your Agency. All telephone charges, for maintenance of mobile phone, currency renewal and calls made by the driver shall be borne by your Agency.
- 22. The vehicle should have comprehensive insurance and same shall be kept valid all the time.
- 23. The vehicle shall be for exclusive use of KPTCL officers and should not be used by your Agency for any other purpose.
- 24. No private parties are allowed in the vehicle and in case the vehicle driver misbehaves with officers and staff, your Agency shall take necessary action to change the driver.
- 25. Your Agency shall change the driver, if not found suitable or desirable by the official and make immediate arrangements to provide a substitute. If the driver is unable to attend or proceeds on leave for whatsoever reason, your agency shall provide substitute without delay. Needless to mention, all such drivers should also be medically fit and antecedents verified by police and also to satisfy any other requirements in respect of the driver mentioned in this contract.
- 26. During the period of operation, the driver should not ordinarily be changed unless desired/allowed by concerned officer of KPTCL. If any vehicle does not report for duty on any day(s) or the driver reports late or there is violation of any other provision of the contract, then an amount calculated on pro-rata basis per day shall be deducted from the monthly bill of that vehicle.
- 27. Your Agency shall arrange payment of Comprehensive Insurance, PF and ESI contribution which covers the vehicle & driver provided by your Agency. KPTCL will not bear any risk or responsibility for any loss or damage to the vehicle and also KPTCL is not responsible for any loss or damages to the vehicle/driver during Riots/Protests/Strikes/Bundhs.

- 28. The calculation of mileage shall be from reporting point to the reporting point and will not be calculated on garage to garage basis. For this purpose, your Agency shall ensure that the odometer of the vehicles provided is properly sealed. In case of any doubt the concerned officer of KPTCL may get odometer of the vehicle checked from any authorized workshop at the cost of your Agency.
- 29. A daily record indicating time and mileage for each vehicle shall be maintained in a log book which should be submitted to the concerned officer for scrutiny & payment of the bills.
- 30. The log sheet will have to be signed by the concerned officers of KPTCL on daily basis to avoid any misuse/pilferage.
- 31. The liability under relevant sections of Motor Vehicle Act 1968 and IPC causing death or permanent disability to the driver during the contract period rests with your Agency only. KPTCL will not entertain any claim in this regard.
- 32. Your Agency shall indemnify KPTCL against all damages/charges arising on account of or connected with the negligence of your Agency or your staff or driver or any person under your control whether in respect of accident/injury to the person or damages to the property of any member of the public or any person or in executing the work or otherwise and against all claims and demand thereof.
- 33. If the vehicles are not provided from the desired location, a penalty of Rs.1000/per day per Vehicle maximum upto Rs.10,000/- per vehicle per month can be
 imposed besides termination of contract. In case of breakdown of a vehicle on
 duty, your Agency shall make arrangement for providing another vehicle within
 one hour.
- 34. The expenses arising out of Traffic offences shall be to the account of your Agency.
- 35. If your Agency fails to comply with any of the conditions of the contract, KPTCL is at liberty to cancel the contract and forfeit the Security deposit.
- 36. The driver should not be under the influence of alcohol while on duty.
- 37. The driver should not use mobile phone while driving the vehicle.
- 38. Driver should be free from any contagious or infectious disease. He should not be suffering from any disease which is likely to be aggravated by service or is likely to render him unfit for service or endanger the health of the public.
- 39. If women drivers are employed, then maternity act shall be followed.
- 40. Your Agency shall issue Photo identity card to all drivers employed by your Agency. The Photo identity card shall indicate a full-face image in colour, full name of the driver and the identification number of the individual to whom the Photo identity card is issued signed by your Agency with the address.
- 41. Your Agency shall provide road worthy vehicles which are purchased in the Year 2015 or later. The vehicles in good working condition shall be provided from 16.06.2022.
- 4. Law Governing of Contract:
- 4.1 The contract shall be considered as having come into force from the date of "Notification of Award" unless otherwise provided in the "Notification of Award.
- 4.2 The laws applicable to the contract shall be the law in force in India. The Courts of Bangalore in Karnataka State shall have exclusive jurisdiction in all matters arising under the contract.

- 5. Contract performance security(Bank Guarantee):
 - a) Contract performance security for an amount equal to 5% of the contract value i.e., Rs.1,76,23,000.00 (Rupees One Crore Seventy Six Lakh Twenty Three Thousand Only) is submitted by M/s.  - b) The above PBG shall be kept till the expiry of 90 days after the end of the contract period.
 - c) Your firm shall extend the bank guarantee for any further period, if so required by the Corporation.
 - d) Security deposit is refundable/bank guarantee can be released after satisfactory completion of the contract period.

6. Termination Clause:

The KPTCL reserves its right to terminate the contract/Hire agreement without assigning any reason whatsoever by issuing 15 days notice at its absolute discretion including but not limited to the following:

- i. If the services are found to be unsatisfactory.
- ii. If the Agency / Company commit breach of any terms and conditions of the Hire agreement/ tender document, KPTCL shall have the following powers.
 - a. To cancel the contract.
 - b. Forfeiture of Performance Guarantee/Security deposit.
 - c. To blacklist or not to consider the agencies future offer for a period of one year.
 - d. To recover from the Agency/Company to the extent of loss suffered by KPTCL from Performance Bank Guarantee submitted by the Agency/Company.
- iii. The Agency/ Company is involved in wrongful billing. In addition to hereto wrongful billing shall also result in the Agency/Company being debarred from participating in any other tender of the KPTCL.
- iv. The engagement is not in the interest of the KPTCL or the KPTCL no more requires any such service.
- v. In case of misbehaviour by driver or the supervisor staff of the Agency/Company, such drivers or supervisor staff will have to be removed from the service. The agency will have to ensure that such drivers, staff will not get appointment with other car agency those are dealing with the KPTCL.
- vi. If the service provider has a record of poor performance in providing and maintaining vehicles against KPTCL requirement, such as abandoning the contract, not properly completing the contract, inordinate delays in providing vehicles, frequent breakdowns of vehicles, accidents, non-compliance to statutory requirements.

7. Termination at the Risk and Cost of your Agency:

In the event, if your Agency fails to provide the services within the stipulated time period, Karnataka Power Transmission Corporation Limited shall be at liberty to carry out the total scope of contract through a Third Party and recover the expenses
