### Preamble:

The Board noted that in trap cases registered against employees/officers of the KPTCL the departmental enquiries are being entrusted to the Hon'ble Lokayukta/Upalokayukta based on the recommendations in such cases. It was noted on the receipt of findings of the enquiry, the Board is the competent authority to take further action on the recommendations of the Hon'ble Lokayukta/Upalokayukta.

It was noted that in State Government when the proposals to take action are inconsistent with the recommendation of the Hon'ble Lokayukta/Upalokayukta only such cases are placed before the Cabinet. In the light of the above, the Board of Directors of KPTCL in the 110<sup>th</sup> Meeting held on 20.06.2018 deliberated the need to delegate powers to Managing Director, KPTCL in such cases and decided to amend Regulation 14(A)(1)(e) of KEB Employees' (Classification, Disciplinary Control and Appeal) Regulations, 1987. Hence the following Order:-

In case, the Managing Director, KPTCL is not in agreeable for the recommendations of Hon'ble Lokayukta/Upalokayukta, the proposal shall be brought before Board seeking further orders."</p> <p><b>2. 14(A)1(e)(ii)</b></p> <p>On receipt of the records under Clause (d) above, Board shall take action in accordance with the provisions of Sub-Regulation (21) and Sub-Regulation (23) of Regulation-11 and Regulation-11A, and in all such cases Board shall be competent to impose any of the penalties specified in Regulation-9 in respect of all the cases against the officers of the rank of Executive Engineers and Equivalent and above.</p>
