ORDER NO: KPTCL/B16/3610/2003-04 BANGALORE, DATED: 21.06.2018

Corporation is pleased to accord approval for treating Dearness Allowance of **45.25%** admissible on the Basic pay in respect of Workmen and Officers of the Corporation as '**Dearness Pay**' with effect from **01.07.2017** as follows:-

1. The Component of 'Dearness Pay' shall be treated as part of Basic Pay for the purpose of calculation of rates of Dearness Allowance, House Rent Allowance and City Compensatory Allowance, Double Wages, Shift Allowance and Charge Allowance.
2. While calculating the component of 'Dearness Pay', the fraction of 50 paise and above shall be rounded off to the next rupee.
3. The rate of 'Dearness Pay' calculated on the pay stages of the existing pay scales of employees are as shown in the Annexure appended to this order.
4. Basic Pay for the purpose of regulating 'Dearness Pay' shall be the Basic Pay in the time scale applicable to the employees. The 'Dearness Pay' shall be variable with reference to increase/ decrease in Basic pay on account of increments, fixation of pay due to promotion etc. as the case may be from time to time.

5. The rates of Dearness Allowance for the period from July-2017 to December-2017 shall be treated as Zero. The first installment of Dearness Allowance shall be admissible from 1st January 2018.
6. Consequent to treating of Dearness Allowance of 45.25% on Basic Pay as Dearness Pay w.e.f 01.07.2017, there shall not be any monetary benefits towards the pay and allowances except the increment released and allowances thereon for the period from 01.07.2017 to 31.03.2018 in line with the provisions contained in the GoK order under reference (5) above.
7. Separate Orders will be issued with regard to regulating House Rent Allowance and other allowances consequent to treating Dearness Allowance of 45.25% on Basic Pay as Dearness Pay w.e.f 01.07.2017.
8. Separate orders will be issued with regard to treating of Dearness Pay as emoluments for the purpose of calculation of pensionery benefits w.e.f 01.07.2017.
