CIRCULAR

Sub: Supply scope of 11kV Switchgears in the turnkey works of substations of KPTCL - Reg.

Ref: 1. Proceedings of the 119th meeting of Board of Directors of KPTCL held on 11/03/2020 (Subject No.119/18).

2. Note No. KPTCL/CEE(T&P)/SEE(T&P)/EE(P)/AEE-P2 of CEE(T&P) approved By Managing Director, KPTCL on 13.05.2020.

KPTCL invites Turnkey Tenders for execution of substation works. 11kV MCVCB and PCVCB Switchgears and accessories are being procured from M/s MEI Ltd under rate contract, based on 4(g) exemption being given under KTPP Act to M/s MEI Ltd by Government of Karnataka and are being supplied to the turnkey works as part of the KPTCL supplied materials for Sub-station works.

M/s MEI Ltd is not in a position to supply the required switchgears due to its low plant capacity. It is resulting in time mismatching between the supply time of 11kV Switchgears and completion stage of substation work by the turnkey contractor which affects time lines of KPTCL Sub-station works.

Even though all other Sub-station equipment are supplied and works are completed by the turnkey contractor, due to non-supply/ non-handing over of 11kV Switchgears by KPTCL to the turnkey contractor at right time, it is resulting in delay in completion/commissioning of targeted substation works of KPTCL.

To avoid delay in completion/commissioning of targeted substation works of KPTCL due to delay/time mismatching in supply of 11kV Switchgears by KPTCL to the turnkey contractor as an owner supplied materials for turnkey works, it is proposed to include the supply of 11kV Switchgears in the contractor's scope of supply in the turnkey works of KPTCL substations along with supply of other equipment.

This would allow the contractor to supply 11kV Switchgears along with other Substation equipment and avoid delay due to delayed supply/ time mismatching in supply of 11kV switchgears and help in completion/commissioning of substation works within the scheduled completion period. Turnkey contractor can purchase 11kV Switchgears required for turnkey works from any of the approved vendors of KPTCL including MEI.

The proposal in this regard was placed in the 119th meeting of Board of Directors of KPTCL held on 11/03/2020. Approving the proposal, Board has authorized the Managing Director, KPTCL to take decision on making provisions for including supply of 11kV Switchgear in the scope of the turnkey contract agency depending upon the production capacity of M/s MEI Ltd.

In compliance to the above, each year, the Superintending Engineer Ele, P&M, KPTCL shall prepare a list of substation works for which 11kV Switchgears are required and also the production capacity of M/s MEI Ltd and place the same before the Managing Director, KPTCL for taking a decision regarding the works for which 11kV Switchgears are to be procured from M/s MEI Ltd under rate contract and works for which supply of 11kV Switchgears to be included in the supply scope of turnkey contract agency.

After obtaining approval for the list from the Managing Director, KPTCL, the approved list shall be circulated by the Superintending Engineer Ele, P&M, KPTCL to all the CEEs and SEEs of KPTCL. In accordance with the approved list, the concerned tender inviting authorities shall suitably include in the tender documents of the respective substation works for inclusion of supply of 11kV Switchgears in the scope of turnkey contract agency OR the concerned procurement authorities shall procure the 11kV Switchgears from M/s MEI Ltd under rate contract basis and supply the same to the turnkey works as part of the KPTCL supplied materials, as the case may be.

The above instructions shall be scrupulously followed.
