#### OFFICIAL MEMORANDUM

Sub: Guidelines for according vendor Approval to the new manufacturers who do not meet the required stipulations- Vendor Development policy reg.

**Preamble:** The manufacturers who have recently set up factory are seeking the Vendor Registration by paying the prescribed fees and furnished the credentials, type test reports (wherever applicable). But these firms do not meet the required stipulations of manufacturing experience of 5 years and satisfactory performance of 2 years of the product/equipment for which Vendor Approval is sought.

The number of New manufactures seeking vendor approval of KPTCL, have increased day by day and the firms are seeking opportunity to supply to KPTCL projects. Hence the subject was discussed in 79th VAC meeting held on 04.10.2021 wherein the committee members opined to have a vendor development policy in KPTCL to develop vendor base and to bring in competition among the manufacturers for cost effective and quality products.

In addition to the regular vendors of KPTCL, the Committee emphasized the need to widen the supplier base by formulating a vendor development program. With a view to develop and promote new vendors for getting faster deliveries of equipment's/materials at competitive rates, it is considered necessary to give opportunities to the manufacturers of equipments/ materials by way of relaxing the qualifying criteria i.e post supply and performance criteria. The relaxation of qualifying criteria shall only be limited to operating experience of the new vendors without diluting the Technical specifications and standards which will be applicable to all the suppliers/ vendors, as a part of Make in India and ATMANIRBHAR BHARAT initiative promoted by Government of India. The committee proposed that a vendor development policy be framed to encourage new vendors duly safeguarding the interest of the corporation.

Accordingly the proposal was put forth before the Management and it was approved to formulate new Vendor Development policy. The following Terms and Conditions are proposed in addition to the regular Vendor approval procedure followed in KPTCL;

# Terms & Conditions stipulated for the new manufacturers for considering them as provisional vendors of KPTCL under VENDER DEVELOPMENT POLICY:

1) The general conditions stipulated for Vendor registration vide circular No: CEE (T&P)/EET2/AEET-5/2014-15/5919-31 dated: 19.9.2014, in KPTCL are applicable for these vendors also except for the relaxation in post supply and performance criteria.

2) The manufacturer who has established manufacturing and testing facilities for offered equipment in India and not meeting the necessary stipulated requirements is eligible to register as new vendor subject to condition, that the equipment offered must have been manufactured in the Indian works and type tested and supplied as on the date of vendor registration.

3) After assessing their production and testing capabilities, provisional vendor approval will be accorded in a phased manner after obtaining additional Bank Guarantee towards performance where ever specified, subject to conditions. In this regard the following separate guidelines item wise are proposed as below:

## I) <u>Sub-Station Structures and Transmission Lines Tower Parts</u> with Bolts, Nuts and Washers.

The firm should have set up a manufacturing plant in India. The firm should have a testing lab, angle straightening machine, cutting & punching machine, drilling machine, bending machine and such other basic machinery required for fabrication of structures and tower parts.

The provisional vendor approval to such manufacturer may be considered in phased

manner as proposed below:

i) Initially such vendor will be approved to supply 110kV/66kV class Substation structures for 2 projects.

- ii) Subsequently after assessing the performance, further it will be extended to **one project** of 110kV/66kV for supply of Transmission Line towers along with **five projects** of 110kV/66kV class for supply of Sub-station structures.
- iii) After the satisfactory supply & erection of Transmission Line towers of one project, the firm may be accorded general vendor approval for supply of 110kV/66kV of Sub-station structures and Transmission Line towers for 110/66kV Voltage class.
- iv) Then such vendor will be eligible for upgradation for supply of Substation structures and Transmission Line towers for **one project** of 220kV.
- v) If the firm's performance is found to be not satisfactory as per the assessment of KPTCL, then the provisional vendor approval accorded remains cancelled and such firms will not be considered for vendor registration in future.

#### II) HT Cables, LT Aluminium Power and copper control cables:

The firm should have set up a manufacturing plant in India. The firm should have manufactured and supplied HT Cables, LT aluminum Power and copper control cables in India. The prospective vendors shall furnish the valid type test reports conducted at CPRI/ERDA as per IS 7098 and IS 1554 / KPTCL Specifications for at least one size of cable and furnish an undertaking that it will conduct the type tests/special tests as per KPTCL stipulations in the event of provisional approval before inspection.

The firm has to furnish, initially performance Bank guarantee of Rupees Five Lakhs for one project for a period of <u>five years</u> which shall be extended till that project completes satisfactory performance of <u>three years</u> since commissioning. The same will be returned after successful completion of <u>three years</u> from the date of commissioning.

The Provisional Vendor approval to such manufacturer will be considered in a phased manner as below:

- i) Initially such firms will be considered for supply of HT Cable, LT aluminum Power and copper control cables for **two projects** of KPTCL of 110kV/66kV class Sub-station.
- ii) After the successful completion of <u>one year</u> from the date of commissioning of above <u>two projects</u> provisional vendor approval will be subsequently extended further for <u>five projects</u>.
- iii) After the successful completion of **two years** of satisfactory performance of atleast **two projects** of 110kV/66kV class, such firms may be considered as eligible for supply to **one project** of 220kV class and regular vendor approval for 110kV/66kV class stations.
- iv) If the firm's performance is found to be not satisfactory as per the assessment of KPTCL, then the provisional vendor approval accorded remains cancelled duly forfeiting security deposit furnished towards the performance guarantee and such firms will not be considered for vendor registration in future.

# III Miscellaneous items envisaged for inclusion like Batteries, 11 kV UG cable termination and jointing kits, Conductor & Ground wire, Conductor & Ground wire Hardware & accessories, Insulator Hardware & accessories, 11kV Switchgear etc.:

The firm should have set up a manufacturing plant in India. The firm should have manufactured and supplied the products for which vendor approval is sought as on the date of Vendor registration. The prospective vendors shall furnish the valid type test reports conducted at CPRI/ERDA as per relevant IS / KPTCL Specifications.

The firm has to furnish initially performance Bank guarantee of Rupees <u>Two Lakhs</u> for a period of <u>five years</u> which shall be extended till atleast one projects completes satisfactory performance of <u>three years</u> since commissioning. The same will be returned after successful completion of <u>three years</u> from the date of commissioning. The Provisional Vendor approval to such manufacturer will be considered in phased manner.

- i) Initially such firms will be considered for supply of products/equipments for two projects of KPTCL to 110kV/66kV class Sub-station.
- ii) After the successful completion of **one year** from the date of commissioning, of above **two projects**, subsequently provisional vendor approval will be extended further for **five projects**.
- iii) After the successful completion of <u>two years</u> of satisfactory performance of atleast <u>two projects</u> of 110kV/66kV class from the date of commissioning, such firms may be considered as eligible for supply to 220kV class one project and regular vendor approval for 110kV/66kV class projects.
- iv) If the firm's performance is found to be not satisfactory as per the assessment of KPTCL, then the provisional vendor approval accorded remains cancelled duly forfeiting security deposit furnished towards the performance guarantee and such firms will not be considered for vendor registration in future.

## IV Guidelines for inclusion of OPGW cable, UG-OFC, ADSS & hardware fittings in the approved list of KPTCL.

- A. Experience of manufacturers Minimum 3 years
- B. Period of satisfactory performance 2 years

#### C. Recognized laboratories for considering their test reports:

- a) The type test on Indigenous equipment for which testing facility is available in India, should have conducted in any independent laboratories approved by Government or accredited by National accreditation body of the country like CPRI, ERDA, etc.,
- b) If the testing facility is not available in India, it should have been conducted in a laboratory of foreign country by National accreditation body of that country.
- c) The Type test conducted in-house by manufacturers shall also be accepted where the specific test facilities are not available in independent NABL accredited body of the country & the tests have been witnessed by a representative of NABL accredited Independent laboratory/ power utility.

#### D. Applicable standards:

- i) OPGW cable & accessories: IEEE-1138-1994, 1138-2009, IEC-60304 & any other standards as & when published by IEEE/IEC/IS.
- ii) ADSS: IEC-60304, IEC 60794, ITU-T recommendations G.652D & prevailing standards as & when published by IEEE/IEC/IS.
- iii) <u>UG-OFC</u>: IEC-60304, IEC-60794-1-2, IEC-60811-5-1, ITU-T recommendations G.652D & prevailing standards as & when published by IEEE/IEC/IS.

#### E. Validity period of Type testsfor acceptance:

5years as per the CEA guidelines-May-2020.

#### F. Guaranteed period:

25 years from the date of purchase.

#### Type test reports:

As per Guidelines for Type tests conducted on Major electrical equipment in Power transmission system' issued by Government of India, Ministry of Power, CEA in May-2020.

Bank Guarantee: Bank Guarantee towards Performance Guarantee from a Public Sector Indian Bank/Scheduled Commercial Bank (in the second schedule of the RBI Act 1934) and the Bank should be covered under the jurisdiction of Indian Laws for the amounts specified against each equipment/materials, shall be furnished for the period specified. The format Annexure-I is enclosed for reference.

The Bank Guarantee shall be in favour of the Chief Engineer, Electricity, Tendering & Procurement, KPTCL, Bengaluru.
