# OFFICIAL MEMORANDUM

#### PREAMBLE:

a) There are only few registered vendors for supply of 400kV class station equipments and line materials in KPTCL approved vendors list.

b) During the Price negotiation, Bidders have raised the issue that they are unable to get reasonable price offer for supply of 400kV class station equipment and line materials as they are loaded to their capacity and limited vendor are approved.

c) During 199th Central Purchase Committee meeting held on 04.07.2023, the issue was discussed in detail and directed to adopt the vendors of M/s. PGCIL approved vendors list as their selection process is same as that of KPTCL.

d) A note regarding the same was put up and has been approved by the Managing Director, KPTCL on 26.07.2023 for putting up the Order.

Hence the following order,

## ORDERS THEREON:

Approval is hereby accorded to adopt the registered vendors of M/s PGCIL as vendors of KPTCL for supply of 400kV class station equipments and line materials in addition to the existing approved vendors of KPTCL.

#### **Terms and Conditions:**

- 1) The vendor shall produce relevant document of M/s PGCIL for having registered as approved vendor.
- 2) The vendor shall produce valid all the type tests reports and Special tests reports for respective equipments/materials as per prevailing IEC/IS standards and KPTCL Technical specification at the time of drawing approval.
- 3) The vendors shall fulfill all the obligations, in case of vendors who share land borders with India viz should have registered with Competent Authority and comply with the Conditions stipulated in the Department Of Expenditure

- orders (Public Procurement No.4) issued vide F7/10/2021-PPD(1) dated 23.02.2023 regarding Restrictions under Rule-144(xi) of General Financial Rule-2017. The vendors shall strictly adhere and comply to the provisions stipulated thereon.
- 4) KPTCL reserves the right to call for any document/credentials for verification during drawing approvals/inspection of materials/equipment by KPTCL to ascertain the manufacturing experience/performance/ authorities. technical suitability of the equipment/ materials. Further KPTCL reserves the right to withdraw/ cancel the vendor approval issued, in case vendor fails to furnish valid documents/credentials to KPTCL for verification, supply of poorquality/defective materials/equipment to the KPTCL projects, performance, poor after sales service, deviations in the technical specifications of KPTCL, misleading to the Corporation etc., by the vendors, without prior notice and assigning any reason for such decision.

5) In case M/s PGCIL imposes any restrictions to any of the vendors the same shall be vis-à-vis applicable to KPTCL also.
